My brother spoke to you tonight.

I went into labour on 23 April 2015. My baby's heartbeat raised to more than 150 beats per minute and an emergency caesarean was done.

Back in the ward, a nurse came to me and told me my baby was in an abnormal position and surgeon had cut the baby's leg while operating.

I was not allowed to see my baby for 12 hours. When I eventually got up, I found my baby in an incubator, It was not working. The cut on my baby's leg was deep. They were waiting for the surgeon to come and See my baby. I was horrified.

My baby's leg was swollen and even I as a lay person could see the leg was infected.

My baby's leg was stitched up on theatre, and we were discharged 6 hours later with pain tablets.

Now 19 months later, my baby can not walk. Important blood flow has been cut off and I was also told the gynaecologist damaged the nerves in my baby's leg.

Please let me know whether you can assist me with a claim against the hospital and the doctor .

THERE SEEMS TO BE A VALID CLAIM ,AND IF YOUR CHILD WILL NEVER HAVE THE FULL USE OF THE LEG THE CLAIM WILL BE SUBSTANTIAL.

I WILL ARRANGE FOR YOU TO SEE MY COLLEAGUE TO TAKE THE MATTER FORWARD AND HE WILL CALL YOU TODAY .

Thank you for the response. I have in my possession, copies of the hospital records.

I have read your email several times in order to understand what the claim would entail. The whole process sounds very complicated and costly.

I have never been involved in litigation before. I take note that you say I must take action now, but you must understand: I am not rich, and I'm not sure if I will be able to afford a lawyer for more than 3 years.

Would you consider payment of R2,000 per month towards the fees in the event that I appoint you as my lawyer? Please do not see this offer as an insult. This is the absolute maximum that can afford at this stage - as you may appreciate that the rehabilitative care is costly at private facilities.

In the event that I do not hear from you again, I will understand that you declined my offer to pay my legal fees in installments, and will respect your position.
